Bids must be accompanied by bid security of at least 5% of the bid amount either in the form of earnest money (refundable) cash deposit on A/c No: 92670601001, Head Office or in the form of Bank Guarantee (Bid Bond) issued in favor of the Bank having validity of 90 days from the last date of bid submission.

Sealed bids must be submitted to Logistic & General Service Department on or before **31st October 2025 (14th Kartik 2082 BS), 5:00 PM.** If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid bond shall remain unchanged. Documents received after this deadline will not be accepted.
7. **Bidders must submit Financial Proposal and Technical Proposal separately on separate envelop.** Technical document will be evaluated first and date, time and place for opening of the financial proposal of technically qualified bidder will be notified and will be opened in the presence of qualified bidders/authorized representatives who choose to attend.
8. The Employer reserves the right to accept or reject wholly or partly any or all the bids without assigning any reason, whatsoever.
